T t is fitting that we celebrate Veterans Day during this month for giving thanks. In addition to rightfully showing respect to the men and women who have served in the United State military, we can think of few better ways to honor our veterans than helping ensure they are not embattled by economic hardship.

Paychecks for Patriots is designed to address the employment needs of veterans by matching them with employers who value the knowledge, skills and attributes attained during military service.

Last year, we held in-person hiring events throughout our three-county region, including at the Marion County Public Library in Ocala.

But this year, for everyone's safety, we and most other regions are offering Paychecks for Patriots as virtual events. Ours takes place on Tuesday, Nov. 10 from 10-11:30 a.m. There is no charge to participate either as a job-seeking veteran or business.

The virtual platform enables veterans to meet in real time with hiring managers, learn about job openings and submit resumes. They will also be able to connect with veterans' services organizations from all three counties.

I asked Henry Ayala, U.S. army (retired) and one of our Local Veteran Employment Representatives, to give me some reasons businesses should hire vets. He gave me a list of 15 benefits, but we'll highlight

"From day one, military personnel are trained to take their jobs extremely seriously," Henry told me. "They have it drilled into them that stupid mistakes, bad decisions or blatant oversights can get their comrades seriously hurt — or worse. You can't unlearn that, and so veterans will usually bring that enviable level of precision into the workplace."

"Veterans also know how to make decisions," he added. "Rather than making snap judgements, veterans have been trained to absorb every single piece of information they can so they can typically be relied upon to make the best choice available."

Henry also noted that veterans have a great work ethic.

"When you're in the military, slacking off isn't an option. Every task you've been asked to do must be done for a reason, and veterans have been trained to understand that. As a result, you can expect veterans to understand the meaning of hard work."

Two further considerations:

- Hiring a Veteran Saves You Money The federal Special Employer Incentives (SEI) program enables employers to hire qualified veteran trainees at an apprenticeship wage and receive reimbursement of up to half of each veteran's salary.
- Hiring a Veteran Means Tax Incentives Businesses hiring eligible veterans may take advantage of tax incentives, including the Work Opportunity Tax Credit (WOTC), Returning Heroes Tax Credit and Wounded Warriors Tax Credit, providing annual incentives of up to \$9,600.
